### 2. Nature of Appointment:

These positions are **purely temporary** on a daily wages / contingent basis. Selected candidates shall have **no right to claim regular appointment**, no future service protection, and no legal standing to pursue any matter related to their hiring, continuation, or termination.

### 3. Submission of Hard Copies:
