

E-TENDERING NOTICE

The SKKT Development Projects Committee (SKKT DPC) of The Sardar Kaura Khan Trust (Registered), Muzaffargarh intends to tender out the following schemes through E-Tendering. The bidders (Firm / Joint Venture) fulfilling the following basic eligibility criteria shall only be considered for further evaluation.

The Govt. Contractors duly licensed by the Pakistan Engineering Council (PEC) in the category C3 & above with relevant code CE-01. In case of Joint Venture, the Lead partner must be registered in the category C3 & above with the relevant code and the other members should at least have registration from PEC. No Foreign Firm (s) is allowed to participate whether as Single entity or Lead member of Joint Venture.

- i Interested contractors may register their firms on E-PADS at <https://punjab.eprocure.gov.pk> by submitting their requisite information.
- ii After registration on E-PADS website <https://punjab.eprocure.gov.pk> interested contractors of eligible category may participate in E-Tendering through E-PADS.
- iii The bidder possessing at least 10 years' experience in relevant category shall submit valid legal entity of the bidder / firm / company e.g. Certificate of Registration from SECP or register of firms or sole proprietorship affidavit or partnership deed, certificate of registration with active Income Tax & Active Provincial Sales Tax on Service under Relevant Authority, Affidavit on Non-Judicial Stamp Paper for No Litigation OR submission of Litigation History of last 10-years before the SKKT Development Projects Committee (SKKT DPC) on or before closing time i.e **11:00 AM** dated **18.03.2026**.
- iv The bidder shall submit Affidavit declaring "Neither the firm nor its Directors, Stakeholders, as a whole or as a part of the firm have ever been black listed / defaulted by any Government agency / department / organization / Donors or settled dispute in plea bargain or Volunteer recovery" MC will check and maintain the record of verification of Blacklisting status of the firm / company / contractor from PPRA website and also from the World Bank debarred / blacklisting list.
- v Contractors / bidders have to upload scanned copies of Original Call Deposit Receipt (CDR) @ 5% of the estimated cost from any scheduled bank in favor of the Chairman Sardar Kaura Khan Trust/District & Sessions Judge Muzaffargarh. All the contractors participating in E-Tendering will be bound to submit their Original CDRs with letter heads to the SKKT Development Projects Committee, Muzaffargarh. Original CDR must be submitted to the SKKT DPC on tender opening date not later than closing time of **11:00 AM** dated **18.03.2026**, in case of non-submission of Original CDR, the contractor will be declared as disqualified from the tendering process in the presence of SKKT Development Projects Committee (SKKT DPC).
- vi Contractors / Bidders have to quote their rates online on item rate basis against each item of approved BOQ / DNIT up to **18.03.2026 before 11:00 AM** after downloading the approved B.O.Q / DNIT of the scheme available at E-PADS. However, the item rates have been reduced and approved upto 20% below of MRS, being a trust entity. As per PPRA Rules, only the item rate shall be accepted instead of overall rate (above / below) quoted by the contractor. Unit of quantities are taken from MRS, incorrect unit quoted by the contractor or the authority shall be adjusted in the formulation of comparative statement. The bids rates quoted by the contractor / bidder on E-PADS shall be downloaded and announced on same date of opening at **11:30 AM Dated: 18.03.2026** in the presence of participating firms / contractors and the SKKT Development Projects Committee (SKKT DPC) in the office of the District & Sessions Judge Muzaffargarh/Chairperson SKKT (Reg.) Muzaffargarh. All pages of bidding documents must be duly signed and stamped by the bidding firm. Un-signed / un-stamped, illegible bids will be rejected.
- vii In case of submission of false information, fake CDR, requisite qualification documents, the contractor will be liable to disqualify as per PPRA Rules and will not be eligible to participate in upcoming tenders of the SKKT Development Projects Committee (SKKT DPC), SKKT (Reg.), Muzaffargarh. Further, his case will be forwarded to PEC and PPRA for initiation of strict Legal Action.
- viii In case the lowest bidder, the successful bidder will submit additional performance guarantee (in shape of CDR) at the rate of **10% of the contract amount** before issuance of work order, which shall be retained till the completion of the entire work.
- ix The SKKT Development Projects Committee (SKKT DPC) is authorized to reject all or any bids due to any reason. The procuring agency shall, upon request, communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.

- xi All the schemes shall be inspected / supervised by the SKKT Development Projects Committee (SKKT DPC) who shall issue the work progress certificate, work completion certificate, quality and quantity of **WORK DONE during the work and** at the time of payment of installment to the successful contractor.
- xii A penalty at cost of 2% of total cost of work shall be imposed on weekly basis, in case the successful bidder fails to complete the work within stipulated contract period. However, the SKKT DPC has full powers to extend the contract period.
