

**MINUTES OF MEETING OF MANAGEMENT COMMITTEE OF SARDAR KAURA KHAN TRUST HELD ON 11.04.2022 IN THE CHAMBER OF DISTRICT & SESSIONS JUDGE, MUZAFFARGARH.**

Meeting of Management Committee of Sardar Kaura Khan Trust was held in the Chamber of the District & Sessions Judge Muzaffargarh on 11.04.2022 at 11:00 A.M. The following Officers attended the meeting under the chairmanship of undersigned: -

It is matter of deep concern that the Deputy Commissioner, Rajanpur and the District Police Officer, Rajanpur failed to make their appearance in the meeting. The Chair observed that the Deputy Commissioner and District Police Officer Rajanpur had not attended meetings even single time since it's constitution by August Supreme Court of Pakistan. The August Supreme Court of Pakistan vide its order dated 11.10.2018 redesignated the Management Committee under the rules titled Sardar Koura Khan Trust, (Management, Supervision and Protection of Land Rules, 2016) by appointing District & Sessions Judge, Muzaffargarh as Chairman. According to rule 4 sub rule 2 of the Notification No. SOR(LG)38-24/2015 dated, Lahore, March 04, 2016 "the

committee shall meet at least once a month to review the progress". It is pertinent to mention that keeping in view the non-appearance of both the aforementioned members vide the minutes of meeting dated 31.01.2022 a separate letter was written to both the numbers by highlighting their absence but they remained least interested to attend the meeting. Thus, the chair decided to bring the conduct of both the officers in the notice of August Supreme court of Pakistan for further necessary action.

The Chair welcomed the participants and the meeting started with the name of Allah, the most beneficent & the most merciful. The items of agenda were deliberated one by one and following decisions were taken in the meeting.

#### **AGENDA NO.01 (SUGGESTION FOR AMENDMENTS IN RULES)**

While dealing with the issues relating to the property of SKKT, it was felt necessary that some amendments be made in the Rules titled "Sardar Kouray Khan Trust (Management, Supervisions and Protection of land Rules, 2016). After detailed discussion, the chair decided to constitute a Committee to submit suggestions for amendments in Rules. The Committee would be comprising on the following members:-

- i) The Senior Civil Judge (Civil Division), Muzaffargarh
- ii) The Land Superintendent, SKKT, Muzaffargarh.

#### **AGENDA NO.2 (AUCTION OF LOTS FOR NEXT 04-YEARS TENURE FROM KHARIF-2022)**

#### **AGENDA NO.8 (MATTER OF APPLICATION FOR CANCELLATION OF LOTS)**

The land Superintendent, SKKT submitted report regarding auction of lots whose four years tenure had been ended. The Management Committee accepted the request of Land Superintendent for the auction of lots. The Chair constituted the committee for completing the auction process comprising of following members: -

The Land Superintendent, SKKT, Muzaffargarh submitted a report that many allottees in whose names lots were auctioned had filed application for cancellation of the lots from their names. The Land Superintendent also proposed that the said lots be included in the upcoming auction process. After detailed discussion the Management Committee decided to accept the application for cancellation of lots from the name of allottee however, the security amount of the allottee would be forfeited and recovery would be made for the period the allottee cultivated the land of Sardar Koura Khan Trust.

**AGENDA NO.3 (TRANSFER OF OWNERSHIP OF LAND PERTAINING TO TRUST FROM DISTRICT COUNCIL MUZAFFARGARH TO SARDAR KOURA KHAN TRUST, MUZAFFARGARH)**

During discussion, the Deputy Commissioner, Muzaffargarh sought further time to follow up the matter regarding transfer of ownership of Trust land. The chair directed the Deputy Commissioner for implementation of the decision of the Management Committee for the transfer of ownership of land to the name of SKKT without further loss of time.

**AGENDA NO.04 (RECOVERY THROUGH LAND REVENUE ACT, FROM ILLEGAL OCCUPIED ON TRUST PROPERTY SITUATED AT RAJANPUR WITH REFERENCE TO LETTER NO.50/SL/SKKT DATED 07.03.2022)**

Since, none had appeared on behalf of Deputy Commissioner, Rajanpur, therefore agenda was postponed for next meeting.

**AGENDA NO.05 (REPORT REGARDING WARA BANDI TO THE TRUST LAND)**

The Superintendent Engineer Canal/Executive Engineer Canal, Muzaffargarh did not attend the meeting nor had they submitted the report regarding WARA Bandi to the trust land. Sheikh Abdul Ahad, Sub Divisional Officer, Irrigation department Muzaffargarh apprised the committee that efforts were being made for the provision of canal water to the trust land. Fayyaz Hussain, Reader, Anti-Corruption, Muzaffargarh informed that inquiry had been marked to proceed against the delinquent officials/ officers of Canal Department who deprived the

canal water to the trust land. He ensured that inquiry proceedings would be completed as early as possible.

**AGENDA NO.06 (OPENING OF TENDER FOR CONSTRUCTION  
BUILDING AT SKKT SCHOOL, JATOI)**

The tendering process regarding construction of Science Laboratory and Computer Lab at Sardar Koura Khan Trust Public School Jatoi as well as for the purchase of 150-chairs for SKKT, Jatoi was initiated. As per report of the Land Superintendent, SKKT, Muzaffargarh none had applied for purchase of 150-chairs while three envelops were received for Construction of Science Laboratory and Computer Lab from different contractors. The Executive Engineer Building pointed out some deficiency in the tendering process. The Management Committee decided to reinitiate the tendering process as per decision of Management Committee in its meeting held on 02.03.2022. The Chair Constituted a Committee to complete the tendering process comprising of following members:-

**AGENDA NO.07 (RECOVERY OF OUTSTANDING LOAN FROM SKKT  
SCHOOLS (ALIPUR, JATOI AND KOT ADDU).**

The above said agenda was partly discussed vide minutes of meeting dated 02.03.2022 whereby Mr. Anwar Khan Sherwani (legal advisor) was directed to hold meeting with Principal SKK Public School, Muzaffargarh and submit report regarding the matter. Mr. Anwar Khan Sherwani, (legal advisor) apprised the Management Committee that he convened a meeting with Principal SKK Public School, Muzaffargarh and as per record SKK Public School, Muzaffargarh had given the claimed amount to the schools (now being run under Sardar Koura Khan Trust, Muzaffargarh) prior to handing over the same to the SKKT. He further apprised that at the time of handing over the said school to the Trust no such claim was raised. During discussion, Land Superintendent SKKT, Muzaffargarh also raised the point that huge amount was spent from the Trust account on the construction of SKK Public School Muzaffargarh and

in this way the Trust might also claim recovery of amount incurred from Trust Account. After detailed discussion the matter was referred to the Deputy Commissioner Muzaffargarh who after hearing the Principal, SKK, Public School, Muzaffargarh as well as Land Superintendent SKKT Muzaffargarh would submit the report in the next meeting.

**AGENDA NO.09 (CHANGE OF BANK ACCOUNT WITH NAME OF SKKT WITH ANY SUIT ABLE BANK).**

The Land Superintendent submitted report that at present joint account bearing No. PLS-6510161451700019 of SKKT was being operated at the bank of Punjab Muzaffargarh in which an amount of Rs. 293630474/- and income certificate worth Rs. 2,164,00,000/- were available in the locker but the Trust was facing operational problems at the bank of Punjab. He pointed out that cheques issued by Trust were not cashed for months. Further mentioned that account had got opened in the name of District Council, Muzaffargarh due to which number of times when fund of local bodies were seized, the operation of financial issues of SKKT was also stopped by the bank. The Management Committee decided that a new account be opened in the name of SKKT, Muzaffargarh at the main branch of National Bank of Pakistan.

**AGENDA NO.10 (RECRUITMENT OF STAFF/TEACHER FOR SKKT PUBLIC SCHOOLS, ALIPUR, JATOI AND KOT ADDU)**

Vide minutes of meeting dated 02.03.2022 it was decided to initiate the process of recruitment of whole staff of SKKT Public Schools, Alipur, Jatoi and Kot Addu. The Committee was also constituted however, the process of recruitment could not be initiated. The Chair decided to initiate the process of recruitment without further delay and Principal of Sardar Kouary Khan Public School, Muzaffargarh was directed to assist the committee regarding recruitment of the staff according to the rules of business framed by the Management Committee.


**AGENDA NO.10 (PAYMENT OF BILLS OF SKKT SCHOOL, KOT ADDU)**

The Principal SKKT school Kot Addu submitted a bill for repairing/polish of furniture worth Rs. 34500/-. The Land Superintendent submitted report that an amount of Rs. 159810/- had already been paid to the Principal SKKT Public School, Kot Addu for the
