The Secretary of the Committee informed about the following agenda of meeting, which was already issued by the Chairman of the Committee.

AGENDA OF NO. 1: TRANSFER OF OWNERSHIP OF LAND PERTAINING TO TRUST FROM DISTRICT COUNCIL, MUZAFFARGARH TO SARDAR KAURA KHAN TRUST.

The Chair discussed the matter regarding implementation of the decision of the Management Committee dated 23-06-2021 for transfer of land in the name of Sardar Kaura Khan Trust.

The Chair informed that the order dated 04-05-2023 of August Supreme Court of Pakistan was very much clear regarding transfer of ownership of land to the Trust and such order requires to be implemented in letter and spirit. The Deputy Commissioner, Muzaffargarh sought time to take up the matter with concerned quarter immediately to seek the approval for implementation of the judgment of the August Supreme Court of Pakistan. The Secretary of the Committee informed that Deputy Commissioner, Muzaffargarh had already moved a request to Government regarding transfer of ownership of land as discussed in the previous meeting vide letter No.111/ADCG/PA dated 28-02-2022 and in this regard Government of Punjab, LG & CD Department responded that there was no provision in the Sardar Kaura Khan (Management, Supervision & Protection Land) Rules, 2016 with respect to transfer of land owned by District Council Muzaffargarh to the Sardar Kaura Khan Trust vide No.SO. ESTATE (LG)2-34/2020 (P-I) dated 24-03-2022. The Chair directed the Deputy Commissioner, Muzaffargarh to move a fresh request to Government of Punjab, LG & CD Department by clearly mentioning all the relevant retrospective facts for approval of transfer of land of Sardar Kaura Khan Trust, in compliance of the judgment of August Supreme Court of Pakistan. Being a time limit case, the Chair directed to Deputy Commissioner, Muzaffargarh properly pursue the matter with all the
