After reciting Holy Quran a discussion was made for preparation of preposals/suggestions for further better utilization of the Waqf property of Sardar Koura Khan in lines with the will and aspiration of late Sardar Koura Khan. It was unanimously suggested that for the better and smooth Management of Sardar Koura Khan trust land a fresh proposal for creation of new Management Committee may kindly be requested to the Honourable Supreme Court of Pakistan for issuance of appropriate direction in this regard to the concerned quarter i.e The Chief Secretary Punjab Lahore and it is also proposed by the committed that new Lot Bandi regarding Koura Khan Trust land be made with digital maping, GIS maping, Google search alongwith manual Lot Bandi from the revenue Officials or experts of Survey of Pakistan etc. It is also suggested that Government Offices etc. which had been established on the land of Sardar Koura Khan to pay rent in future since their occupation. The brilliant and position holder students of the Districts Muzaffargarh and Rajanpur will be awarded Sardar Kaura Khan Merit Scholarship as the trust land is situated in both these Districts. Further more the committee unanimously suggested to make request to the Honourable Supreme Court of Pakistan for creation of Poly Technical institute/ College as well as Sardar Koura Khan Technical Education University at Muzaffargarh and Government of Punjab shall also be directed by the august Supreme Court of Pakistan to surrender or alienate 1500 acres land situated in Mauza Rakh Khanpur near to the City Muzaffargarh which is still barren, for creation of above said Poly Technical institute and University etc. As a compensation to the trust of Sardar Koura Khan for the utilization of trust land of Sardar Koura ce 1894 to2018. The other TORs/n proposals were also discussed regarding auction/reassessment of lease money, formation of secretariat of the trust, appointment/recruitment of officials, I.T staff, Management of record of trust land etc.
