#### AGENDA NO.12

# (STATUS OF MUHAMMAD SAJID MUSTAFA, CO-OPTED MEMBER AND COMPLAINTS) (NOMINATION OF PRESIDENT BAR ASSOCIATION, MUZAFFARGARH AS MEMBER)

5. First of all, to complete the composition of Management Committee with reference to the status of Muhammad Sajid Mustafa as co-opted member in view of observations made vide para No.2 of the minutes of meeting dated 03.05.2024 and nomination of President Bar Association, Muzaffargarh as member of the Management Committee Agenda No. 12 was taken up for consideration. The Management Committee after discussion approved the nomination of President Bar




Association, Muzaffargarh as Member of the Management Committee. However, regarding Muhammad Sajid Mustafa, it was noticed that he is allottee/lessee of 11 lots bearing lot No. 11, 182/1, 183/1, 183/2, 194/1, 194/2, 195/1,196/1, 197/2, 202/2, 205/3 of Mouza Rampur-II. According to the data provided by the Land Superintendent, Sardar Kaura Khan Trust, Muzaffargarh, he is defaulter in lot No. 171/1, 196/2 for the period Rabi-2019 to Kharif-2019, 206/3 and 165/2 for the period Rabi-2019 to Kharif-2020 of Mouza Rampur-II. According to the data of remaining lots revealed that he has not deposited the lease amount as per rules In view of the above, all the members of the management Committee unanimously not approved the nomination of Muhammad Sajid Mustafa as co-opted member. Accordingly, he is de-notified as co-opted member of Management Committee of Sardar Kaura Khan Trust with immediate effect.

- 6. An application filed by Mr. Muhammad Sajid Mustafa against Mr. Abdul Karim, Senior civil Judge (Civil Division), Muzaffargarh now posted at Rajanpur, Mr. Sahib Gul Khan Baloch, Civil Judge, Muzaffargarh and Staff Officer to District & Sessions Judge, Muzaffargarh was discussed. The application of same nature was also moved by him before the Hon'ble Lahore High Court, Lahore which has been filed vide letter No.7386/DDJ/MNP/Dy dated 31.05.2024, hence, the Management Committee decided to take no further action.
- 7. Muhammad Sajid Mustafa, has pointed out that on his application an inquiry was conducted by Mr. Abdul Karim the then Senior Civil Judge (Civil Davison) Muzaffargarh but so far no order has been made by the Committee. Perusal of file revealed that initially inquiry was contacted by Mr. Abdul Kairm, Senior Civil Judge, Muzaffargarh and the then then Chairman SKKT, Muzaffargarh entrusted the same to Mr. Sahib Gul Khan Baloch, Civil Judge, Muzaffargarh He submitted the report on 01.03.2024 and both my learned predecessor have not passed any order in the previous meeting, hence the same be submitted in the next meeting for further action in the matter.

#### AGENDA NO.1:

### i. (APPROVAL AND SUBMISSION OF THE BIANNUAL REPORT)

8. As per decision of the Management Committee vide its minutes of meeting dated 03.05.2024 biannual report showing composition of Management Committee, objective and projects of the Trust,



as well as complete details of Income and Expenditures was presented before the members of the Management Committee. After detailed discussion the Management Committee approved the same for onward transmission to the Supreme Court of Pakistan. The Management committee also decided to place it on the Website of the Trust.

#### ii. REVISED ENTRY IN MUTATION

9. The Deputy Commissioners, Muzaffargarh and Rajanpur apprised that the revised entry of the mutation in favour of Sardar Kaura Khan Trust, in pursuance of the decision of the Management Committee dated 07.08.2023 and order of the Supreme Court of Pakistan dated 04.05.2023 and 13.07.2023 has been sanctioned. The Chair directed to submit the certified copies of the same for perusal and record. The chair as well as Members of the Management Committee appreciated the decision made by the Deputy Commissioners, Muzaffargarh and Rajanpur. This would be helpful for registration of Trust.

#### AGENDA NO.2: (REGISTRATION OF TRUST.)

- 10. The Management Committee discussed the matter for registration of Trust keeping in view the decision of Management Committee dated 08.03.2023. The Additional Deputy Commissioner (G), Muzaffargarh briefed the Management Committee about the process of registration of Trust. He referred a letter No.49/AC dated 21.02.2024 of the Office of the Assistant Commissioner Jatoi whereby following deficiencies were pointed out for further process of Trust registration:
  - i. Application to Assistant Commissioner concerned.
  - ii. CNIC Copies of Author and Trustees.
  - iii. Affidavits of Authors and Trustees (Section-12)
- iv. Trust property attested documents in the name of trust (Seciton-14)
- v. Instrument of trust (section-б)
- vi. Trust effective controller, Head letter.
- vii. Trustees Living abroad (details)
- 11. According to him, reply of the said letter is still awaited from the office of Sardar Kaura Khan Trust. The Land Superintendent, SKKT, Muzaffargarh showed his un-awareness for receipt of any such letter. The Chair after perusal of the letter directed the land Superintendent to make up the deficiencies pointed out in the letter and transmit the reply of the same within two days. The Chair also directed the Additional Deputy Commissioner (G), Muzaffargarh to provide the necessary documents pertaining to Revenue Office. The Chair further directed to accelerate the



process of registration of Trust to avoid further complications towards the payment of taxes.

#### AGENDA NO.3:

#### (DETAIL OF "DARYA BURD AND CULTIVATED" LOTS)

Darya Burd/uncultivated Lots. As per the decision of the Management Committee in its meeting dated 03.05.2024 the report be transmitted to the Assistant Commissioner, Jatoi with the direction to physically inspect the Land and submit a detailed report regarding each lot whether the same are completely Darya Burd or partially/incapable to cultivate. The report should also contain the information whether it is possible to cultivate the wheat crop and to further lease out for any specific season in the said year.

#### AGENDA NO.04: LIST OF DEFAULTERS AND RECOVERY STATUS WITH DOCUMENTARY PROOF.

13. The land Superintendent, SKKT, Muzaffargarh submitted a list of defaulters 65 in numbers bearing No. 761/SL/SKK dated 26.08.2019 containing an amount of Rs. 14,468,359/- for the period Kharif-2015 to Rabi-2019 and list of 224-defaulters for the period Kharif-2019 and 2020 containing an amount of Rs. 69,769,565/- Furthermore, the latest report prepared for total number of auctioned lots for the current running period i.e. from Rabi-2021 to onwards show that an amount of Rs.268,407,189/- is still outstanding on the part of lessees. The Management Committee showed serious reservations for such huge amount of outstanding on the part of lessee/defaulters. The Management committee directed the Land Superintendent, SKKT, Muzaffargarh to issue the notices to all the defaulters to deposit the outstanding amount within 30-days, failing which, lots might be cancelled in view of rule 8 (1) (ii) of Sardar Kaura Khan (Management, Supervision and Protection of Land) Rules 2016 except of the lessees who had been granted one time relaxation for deposit of advance amount in the minutes of the meeting dated 03.05.2024. The whole recovery proceedings shall be supervised by the Additional Deputy Commissioner (G), Muzaffargarh. Furthermore, the lessee who failed to deposit the outstanding arrears list be provided to the Trust and recovery of the said amount be made as arrears of land revenue.

#### AGENDA NO.05:-(RECOVERY OF RENT OF BUILDINGS CONSTRUCTED ON THE LAND OF TRUST)

14. According to the report of Land Superintendent of SKKT, Muzaffargarh, the District Judiciary and Police Department have been consistently paying rent. However, the Municipal Committee, District Support, RESCUE-1122, and Tehsil Complex have yet to fulfill their rent obligations as per following details:-

15. The District Police Officer, Muzaffargarh apprised that for the payments of lease amount the departments demand the lease agreements with the Trust and requested for execution of lease agreements. The Land Superintendent was directed to enter a lease agreement on approved rates as per Law with the concerned departments. The Land Superintendent was further directed to send letters to the Incharge of the offices occupying the Trust land for payments of lease amount and copy be endorsed to the Deputy Commissioner and District Police Officer, Muzaffargarh for information and further necessary action.

## AGENDA NO.06: (DETAIL OF BANKS ACCOUNTS, CURRENT BALANCE AND DISCUSSION ON LUCRATIVE SCHEMES FOR TRUST.)

16. The Land Superintendent SKKT, Muzaffargarh submitted report/current balance of following banks:

According to the report of Land Superintendent, SKKT, Muzaffargarh National Bank of Pakistan, Muzaffargarh is providing highest profit at the rate of 22.50% and proposed that all the amounts of Trust be shifted to single account maintained with National Bank of Pakistan, Main Branch, Muzaffargarh. The Management Committee decided that all the amounts of Trust lying in different banks accounts be shifted in the account of National Bank of Pakistan, Main Branch Muzaffargarh. However, it was noticed that withholding Tax is consistently being deducted from Trust profit by the National Bank of Pakistan, Main Branch Muzaffargarh. It's imperative to highlight that Sardar Kaura Khan Trust is exempted from such deductions as per tax regulations. Thus, the deduction of withholding tax on gross profit is unwarranted and needs to be rectified promptly. The Manager National Bank of Pakistan, Main Branch, Muzaffargarh was directed to refund the amount of wrongful deduction of withholding tax from the Trust account without delay vide letter No.35/SKKT dated 09.05.2024, however, the report was still awaited. Fresh report be obtained from the National Bank of Pakistan, Main Branch, Muzaffargarh regarding refund of withholding tax with a certificate that 22.50% interest was being credited to the Trust account.

18 Furthermore, reports of Land Superintendent, SKKT, Muzaffargarh and Staff Officer Sessions Courts, Muzaffargarh regarding RIC scheme 9150 National Saving Center, Muzaffargarh were perused. The Land Superintendent, SKKT, Muzaffargarh was directed to obtain a detail report about profit credited to account from Saving Centre Muzaffargarh and put up in the next meeting.

#### AGENDA NO.07: (PROPOSED REPLY OF AUDIT PARAS.)

19. The proposed replies submitted by the Land Superintendent, SKKT, Muzaffargarh was found unsatisfactory. He was directed to submit detail annotated reply along-with all relevant documents in next meeting.

#### AGENDA NO.08: (REPORT/SUGGESTIONS REGARDING PERFORMANCE OF ALL THE PRINCIPAL/TEACHERS AS WELL AS STANDARD OF THE EDUCATION)

20. The report was not submitted by the Committee constituted in pursuance of decision of Management committee dated 03.05.2024 vide

SKI. Trust/District Session Jude Muzaffargarb Endst. No 36/SKKT dated 13.05.2024. It was noticed that Mr. Javed Aziz Qureshi, Advocate has been replaced as member of the Management Committee, thus, the committee would be reconstituted. During discussion number of problems as well as suggestions were put by the Principal Sardar Kaura Khan Pubic School, Muzaffargarh. The Chief Executive Officer (Education), Muzaffargarh also attended the meeting and ensured full cooperation for improvements in working of teaching staff and quality of education to the students studying in the School under the establishment of Trust. The Management Committee after detail discussion decided to constitute a recruitment Committee for the selection of Principals at the first instance on urgent basis. Reportedly, the Rules of Business of Sardar Kaura Khan Public School, Alipur, Jatoi and Kot Addu approved by the Management Committee are still holding the field, however, if the recruitment Committee may feel it necessary some relaxations/amendments for the selection of highly qualified and efficient Principals as well as teaching/non-teaching staff the Committee may proceed with the same after approval from the Chair as well as Deputy Commissioner, Muzaffargarh for initiating recruitment process. It was noticed that in all the three schools female teachers were appointed, hence, it was also suggested that there should be a female Principal, However the matter was left on the recruitment committee.

## A. APPLICATION MOVED BY MIAN MUHAMMAD ARSHAD ADVOCATE FOR APPOINTMENT OF LAND SUPERINTENDENT OF SKKT, MUZAFFARGARH

27. One Mian Muhammad Arshad Advocate moved an application for appointment of Land Superintendent, SKKT, Muzaffargarh under Sardar Kaura Khan (Management, Supervision and Protection of Land) Rules 2016 on the ground that Mr. Muhamad Rafiq presently performing his duty as land Superintendent SKKT, Muzaffargarh has been retired from the establishment of Zila council and he is receiving monthly salary from the Trust account in violation of Rules. On query, Muhammad Rafiq land Superintendent apprised that he was given additional Charge of the Land Superintendent of Sardar Kaura Khan Trust, being PS to Chairman Zila Council Muzaffargarh. Furthermore, he has been retired from Govt. service/establishment of Zila Council. After perusal of the relevant Rule referred as 2 (1) (e) of the Sardar Kaura Khan (Management, Supervision and Protection of Land) Rules 2016 while described as under:-

"Land Superintendent" means a person, having knowledge about land management, appointed or posted by Chairman District Council Muzaffargarh from the administrative setup of the District council."

The Management committee after considering the stance 28. taken by applicant Mian Muhammad Arshad Advocate and perusal of above quoted rules unanimously decided that appointment of Land Superintendent was the sole duty of Chairman of the District Council, Muzaffargarh and the Deputy Commissioner, Muzaffargarh having charge of Administrator/Chairman of the District Council Muzaffargarh was under obligation to appoint a suitable Land Superintendent of the Sardar Kaura Khan Trust, Muzaffargarh from the administrative setup of District the Management Committee council. In view of the application, Commissioner, Muzaffargarh/ unanimously directed the Deputy Administrator/Chairman Zila Council, Muzaffargarh to consider the appointment of Land Superintendent of Sardar Kaura Khan Trust, from the administrative setup of the District Council as laid down in Rule 2 (1) (e) of the Sardar Kaura Khan (Management, Supervision and Protection of Land) Rules 2016. However, till the appointment, the present superintendent shall continue to perform his job/responsibility.

Two others anonymous applications were also filed against Mr. Muhammad Rashid Anwar Principal Sardar Kaura Khan School, Alipur/Jatoi. The Management Committee unanimously accepted the resignation tendered by Mr. Muhammad Rahsid Anwar w.e.f. 16.05.2024 and the complaints were entrusted to the Chief Executive Officer (District Education Authority), Muzaffargarh to enquire about the allegations and submit fact-finding report to proceed further in the matter.

#### 2. COMPLAINT MOVED BY M. TAHIR AGAINST STAFF OF TRUST.

31. The complaint filed by Muhammad Tahir and the reply submitted by the Land Superintendent SKKT, Muzaffargarh, was entrusted to Ch. Muhammad Asif, Additional District & Sessions Judge,



Muzaffargarh with the direction to enquire in the matter and submit fact finding report to proceed further in the matter.

#### 3. <u>APPLICATION MOVED BY ANWAR KHAN SHERWANI,</u> ADVOCATE

32. Mr. Anwar Khan Sherwani, Advocate filed an application addressing to the Chief Justice, Supreme Court of Pakistan, copy of which was forwarded to the Hon'ble Lahore High Court as well as this office of Chairman Sardar Kaura Khan Trust. - In light of ongoing challenges associated with the current system of leasing out the Trust's 417 lots, which collectively measure 83074-kanals & 08-Marlas, the management committee has undertaken a strategic review to enhance the efficiency and profitability of land management. Historically, the Trust has faced several significant challenges, including non-compliance with auction rules by lessees, premature surrender of leases, and substantial outstanding dues amounting to Billions. As per data provided by the Land Superintendent, SKKT, Muzaffargarh at present total amount of Rs.268,407,189/- is recoverable/outstanding on the part of lessees. Such defaults are affecting the performance of the Trust.
- To address these issues and enhancement of Trust income 55. proposal/discussion was made to lease out the agricultural land to any organization which may utilize the land efficiently and secure a valuable income for Trust. During discussion, it was pointed out that Fongrow (PVT), Ltd. subsidiary of Fauji Foundation is one of the most reputable and financially stable organization in the country having vast experience and resources in agriculture ventures and livestock. The Management committee after detail discussion agreed to make an offer for leasing out the land to FonGrow (PVT) Limited subsidiary of Fauji Foundation. Therefore, a letter for expression of interest that Sardar Kaura Khan Trust, is willing to make to lease out the land to Fongrow (Pvt) Limited (Fouji Foundation) However, before leasing out the land to aforesaid foundation the terms and condition would be discussed in the Management Committee and the comparison of income viz-a-viz auction of lots in present scheme would be evaluated. The agreement would be made after detailed discussion and approval of the Management Committee.
