

**MINUTES OF MEETING OF MANAGEMENT COMMITTEE OF SARDAR KAURA KHAN TRUST HELD ON 12.08.2020 IN THE COMMITTEE ROOM OF DISTRICT & SESSIONS JUDGE, MUZAFFARGARH**

The chair welcomed the participants and the meeting was started with the name of Allah, the most beneficent & the most merciful. The items of agenda were deliberated one by one and following decisions were taken in the meeting.

**Medical Hospital**

It has been proposed by the committee that a project of trust hospital worth of Rs. 100.00 Million in the name of Sardar Kaura Khan trust hospital may be constructed at the land of Sardar Kaura Khan Trust at Jatoi for the welfare of the public. The hospital shall provide free of cost treatment to the poor and other people keeping in view their financial status as per patron of Indus Hospital or other Trust Hospital. The Deputy Commissioner shall convene a meeting with M.S/C.E.O, Indus Hospital as well as other private hospitals of well repute and after obtaining feasibility report the matter shall be considered in the next meeting for launching the project.

**Trust Schools**

The committee has already adopted the school vide order dated 27.01.2020 by the erstwhile chairman Mr. Sohaib Ahmad Rumi, District & Sessions Judge, Muzaffargarh the salary of staff is being released. The schedule

of fee will be according to the paying capacity of the students. The Children of martyred, children of trust staff and poor people will be provided education free of cost and the remaining students shall be charged category wise. For this purpose a committee headed by ASJ-I of respective sub-divisions, Assistant Commissioners and D.E.O. (Education) is hereby constituted. The Deputy Commissioner, Muzaffargarh has given consent to handover the building to trust alongwith all fixture & furniture and necessary repair of the building.

The Management Committee has further proposed for the construction of Sardar Kaura Khan Trust School at Rajanpur. Tehsildar Rajanpur has been asked to submit report regarding the land for construction of school at District Rajanpur.

#### **Sardar Kaura Khan Trust, School Alipur**

Keeping in view the continuous unrest between staff (vice principal, Computer Operator, Clerk and Mali), of sardar Kaura Khan Trust School, Alipur the Management Committee has decided to appoint a principal of Sarkar Kaura Khan Trust, Alipur. Office has been directed to issue the advertisement for appointment of Principal.

#### **Renovation of Trust Office Jatoi**

The Management Committee has discussed the matter for renovation of Sardar Kaura Khan Trust office, Jatoi, In this regard, the Management Committee decided to get a report from Building department. So, S.D.O, Building is directed to provide the rough cost estimate for renovation of trust office Jatoi.

#### **Trust Vehicle**

It has been decided by the Management Committee that a suitable vehicle Jeep or car worth of Rs. 1.5 Million will be purchased, so as the work of the Trust can be run smoothly.

#### **Compliance of Supreme Court Order**

Lot No. 03 Jatoi Shumali contain 03—K and 06---Marla where shops, privates school and Masjid has already been constructed illegally. The Deputy Commissioner /Member of Committee has taken task to get fresh detailed report from ADC (R) Jatoi and resolve the matter as soon as possible and to get the land vacated if it is found illegally occupied.

#### **Honorarium for Legal Advisor**

The Management Committee has decided to appoint Mr. Anwar Khan Sherwani, Advocate as legal advisor for the financial year-2020-21. annual honorarium is being fixed Rs. 2,50,000/- which shall be paid to him in four equal quarterly installments or in lump sum at the end of year as per his choice. Office is directed to issue the offer letter in this regard.

#### **Trust matter of District Rajanpur.**

As regard payment to the contractor, who constructed two rooms, six wash room, one security guard room in sub-division Sardar Kaura Khan Trust School Jatoi, the Management Committee has decided to obtain completion report and estimated cost from XEN Building Department Building, D.G. Khan as well as two private firm of well reputation.

The meeting was culminated with a vote of thanks to all the participants.


