

The chair welcomed the participants and the meeting started with the name of Allah, the most beneficent & the most merciful. The items of agenda were deliberated one by one and following decisions were taken in the meeting.

AGENDA NO.1 CONSTRUCTION OF MEDICAL HOSPITAL, AT JATOI PROGRESS REPORT FROM DEPUTY COMMISSIONER, MUZAFFARGARH. WITH REFERENCE TO THE MEETING DATED 12.08.2020.

The proposal regarding establishment of Medical Hospital in the name of Sardar Koura Khan Trust, for the welfare of the public at the land of Sardar Koura Khan Trust, was discussed and it was decided that the hospital shall provide free of cost treatment to the poor and other people keeping in view ineir financial status as per patron of Indus Hospital or other Trust Hospital. A Committee comprising of the following members is hereby constituted who after the spot inspection submit feasibility report:-

- 1. Mr. Mudassir Hussain, Senior Civil Judge, (Crl. Division), M.Garh
- 2. The Chief Executive Officer (Health), Muzaffargarh.
- 3. The Chief Executive Engineer, Building Department, Muzaffargarh.
- 4. The Deputy District Health Officer, Jatoi.



AGENDA NO. 2 REPORTS FROM DEPUTY COMMISSIONER, RAJANPUR ALONGWITH KHASRA NUMBERS WITH REFERENCE TO THE MEETING DATED 12.08.2020,

The Deputy Commissioner, Rajanpur has not appeared however, the representative is present. He has been directed to submit detailed report of Khasra Nos of Land situated at District Rajanpur in the next meeting.

AGENDA NO. 3 RENOVATION OF TRUST OFFICE AT JATOI

The matter regarding renovation of Trust office at Jatoi was discussed however, Syed Mansoor Ahmad Bokhari, member of the management committee showed some reservations, hence, the chair postponed the issue.

AGENDA NO. 4 CONSTRUCTION OF TWO ROOMS, SIX WASH ROOM, ONE SECURITY GUARD ROOM IN SARDAR KAURA KHAN PUBLIC SCHOOL, JATOI

Agenda No.4 was discussed in detail. All the members actively participated in the discussion and given their valuable remarks. Syed Mansoor Ahmad Bokhari member of the management committee took the plea that according to the Judgment of August Supreme court of Pakistan educational institutions may be established at the land of Sardar Koura Khan Trust, but the same shall be run by the Provincial Government and expenditure from Trust account are not admissible. After perusal of record and discussion it has been concluded that all these Schools have already been taken up by the Trust and being run under the Management Committee. A large number of students are getting education and the basic object of Trust is welfare of the poor people of this vicinity, hence, it is decided that Management Committee will continue to take all steps for the improvement of these institutions. During discussion it revealed that wash rooms and security guard room already constructed are sufficient, however, it was suggested by the Deputy Commissioner, Muzaffargarh that if the wash rooms are affiliated with building the issue will be resolved. The Management Committee approved the scheme to this extent. Hence, the chair directed the Executive Engineer, Building Department, Muzaffargarh to submit rough cost estimate with consultation of the concerned Principal to proceed further in the matter.

AGENDA NO. 5 CONSTRUCTION OF WALL OF SARDAR KAURA KHAN PUBLIC SCHOOL, KOT ADDU

The above said agenda was discussed in detail and it was noticed that boundary wall of Sardar Koura Khan School, Kot Addu from one side has been fallen and due to which school administration as well as children are facing serious problems. The Management Committee decided to construct the wall after completing the codal formalities. It was resolved that rough cost estimate be obtained from the Executive Engineer, Building Department, Muzaffargarh. Accordingly the Executive Engineer, Building Department, Muzaffargarh is directed to submit rough cost estimate to this office within a week to proceed further in the matter.

AGENDA NO.6 CONSTRUCTION OF EXTRA ROOMS OF SARDAR KAURA KHAN PUBLIC SCHOOL, ALIPUR

It was pointed out that due to admission of large number of students in Sardar Koura Khan Public School, Alipur construction of two extra rooms of Sardar Koura Khan, Public School Alipur is indispensible. Therefore, the Management Committee approved the suggestions. The Management Committee decided to construct the rooms after completing the codal formalities. It was resolved that rough cost estimate be obtained from the Executive Engineer, Building Department, Muzaffargarh. Accordingly the Executive Engineer, Building Department, Muzaffargarh is directed to submit rough cost estimate to this office within a week to proceed further in the matter.

AGENDA NO.7 INCREASE OF SALARY OF STAFF OF SARDAR KOURA KHAN TRUST, SCHOOLS,

It was pointed out that during last three years no increase was made in the salary of the staff of the Sardar Koura Khan Trust, Schools. Keeping in view the price like, the Management Committee decided to increase the 20% salary of all the staff working on current running salary in Sardar Koura Khan Trust, Public Schools from July, 2021.

AGENDA NO. 8 PURCHASE OF VEHICLE JEEP OR CAR FOR TRUST

The matter regarding purchase of vehicle Jeep or Car for Trust was discussed however, Syed Mansoor Ahmad Bokhari, member of the Management Committee showed some reservations, hence, the chair postponed the issue.

In addition to the aforesaid agenda Syed Mansoor Ahmad Bokhari, (Member) raised the point that the ownership of land pertaining to Trust still lying with District Council Muzaffargarh and it should be transferred in the name of Sardar Koura Khan Trust, Muzaffargarh. All the members unanimously agreed the point hence, the Deputy Commissioner, Muzaffargarh was directed to get incorporate the ownership of land in the name of Sardar Koura Khan Trust, Muzaffargarh. Syed Mansooor Ahmad Bokhari, further pointed out that land of the Trust is being misused by the official of Trust and fake entries regarding are being بنجر قديم&دريا برد incorporated in the revenue record. He further pointed out that during the auction, Land Superintendent Sardar Koura Khan Trust given the wrong information with collusion of the land grabbers. This matter is thoroughly discussed and resolved that Mr. Mudassir Hussain, Senior Civil Judge (Crl. Division), Muzaffargarh is deputed to visit and physically verify the status of the land with the help of Revenue Staff. The Deputy Commissioner, Muzaffargarh is directed to depute Revenue Staff for the assistance of Mr. Mudassir Hussian, Senior Civil Judge (Crl. Division), Muzaffargarh.

Syed Mansoor Ahmad Bokhari (Member) further suggested that there should be university of education at Muzaffargarh under the Trust. This matter will be discussed in the next meeting.

An application presented by Mr. Tahir Bashir, Principal, Sardar Koura Khan Public School, Muzaffargarh for recovery of outstanding loan from S.K.K.P Schools (Alipur, Jatoi and Kot Addu) which will Lediscussed in the next meeting.

The points raised by Syed Mansoor Ahmad Bokhari, are appreciated and he is requested to further give the suggestions for the development of Trust and welfare of the peoples of Muzaffargarh.

The meeting culminated with a vote of thanks to all the participants.
